

ACFM 2023 Market Screening is a service for ACFM 2023 participants.

ACFM participants, including buyers, can get an access to not only the line-ups of various sales companies but also some of the BIFF Official Selections through Market Screening. This year, Market Screening will be held online for 4 days on the ACFM 2023 Online Site, providing a convenient and safe environment.

Mon, 17 July, 10:00 ~ Fri, 15 September, 23:59

#### Market Screening Period (KST)

Sat, 7 October, 10:00 ~ Tue, 10 October, 23:59

### **Screening Registration**

#### 1. Deadline for Purchase Screenings & Film Information Entry

- · Purchase Screenings: Wed, 13 September, 23:59 (KST)
- · Upload Screenings & Film Information Entry: Fri, 15 September, 23:59 (KST)

- Only Features Films, Short Films, or TV content within 120 minutes with distinguishable genres and synopsis are allowed for Market Screening.
- The screening file must be uploaded before 15 September for the final check.
- ACFM will not be responsible for any issues caused due to late upload or submission.
- After uploading the file, we recommend playing the video file on 'My Page' to check for any errors.

- Please make sure to fill in the film information accurately, as it will be publicly available on the ACFM 2023 Online Site.
- Please note that any information modified after the deadline will not be reflected on the website.
- ACFM will not be responsible for any issues caused by incorrect entries.
- All screening files will be discarded after the closure of Market Screening.


#### 2. Viewer's List

- During the Market Screening period, exhibitors can check the Film Viewer Statistics and Viewer's List for their registered films in real-time on 'ACFM Official Website > My Page > Market Screening'.
- The Viewer's List provides access history of Market Badge holders.
- The final Viewer's List will be sent via email after the closing of ACFM 2023.


#### 3. Screening Eligibility

- Eligibility to enter Market Screening is as follows:
  - ACFM 2023 Market Badge holders
  - APM 2023 Badge holders
- To access the 'ACFM 2023 Online Site > Market
   Screening' tab, purchasing a Market Badge is mandatory.






1. Click the 'Login' button at the top of the right on the ACFM Official Website.




2. Click 'My Page > Booth > Online Booth > Screening > Add Screening'.







3. Fill in the required blanks and click 'Save and Next' button. You must enter all information in English.




4. Upload 'Poster' and 'Still Cut' images, and then click 'Save and Next'.








5. Please upload the appropriate file for each fields according to the <u>'Market Screening Regulations'</u>.




- Please note that it will take some time to convert the video when uploading a video file.



  - You can freely add or edit screening information until Wed, 15 September, 23:59 (KST).


#### \*\* 3 Ways to check submitted information:

- Go to 'My Page > Booth > Screening'.








Click 'Registration > Market Screening' and click on 'Market Screening Registration' button.






3. Select the number of sets and make the payment. Please note that you can only purchase additional screenings through card payment.




- After the payment is completed, you can upload the screening file by clicking the 'Go to Film Information Page' button below or clicking 'My Page > Market Screening > Add Screening'.




